# Re: Airdrie City Plan & South Airdrie Area Structure Plan Amendments

Please find enclosed a new application to the CMRB with the same material as the IERF – 2021 -01 application but with an updated alignment table. Sections in the alignment table were updated to better clarify the proposed statutory plan amendments. The statutory plan a amendments include the **Airdrie City Plan (MDP)** & **South Airdrie Area Structure Plan (ASP)**.

On April 06, 2021, Council held a public hearing and gave first and second reading to Bylaw B-33 /2020 and Bylaw B-34 /2020 to amendment the existing Airdrie City Plan and South Airdrie ASP that was adopted in 2017 and 2012 respectfully .

The Airdrie City Plan is considered the City's Municipal Development Plan and is keeping with Section 632 of the Municipal Government Act. The Airdrie City Plan provides a framework used by the City of Airdrie to address long-term community development, land use and responsible growth. The purpose of a Municipal Development Plan is to shape the City of Airdrie's urban form and direct development and implementation of more detailed plans

The City of Airdrie utilizes two area structure plans to guide future development and both are considered area structure plans in keeping with Section 633 of the Municipal Government Act. A Community Area Structure Plan (CASP) is a high level ASP that provides a broad-based planning framework for new community development. A Neighbourhood Structure Plan (NSP) is a detailed ASP that focuses on a smaller area within an approved CASP and provides a higher level of detail for the development within the defined plan area boundaries.
