Please find enclosed Rocky View County's application for review and approval of a the Highway 1/Old Banff Coach Road Conceptual Scheme and supporting amendment to the Central Springbank Area Structure Plan (proposed Bylaws C-8120-2020 and C-8121-2020) by the Calgary Metropolitan Region Board (CMRB).

Description of Bylaws

Bylaw C-8120-2020 is a bylaw to amend the Central Springbank Area Structure Plan to provide for the proposed Highway 1 / Old Banff Coach Road Conceptual Scheme.

Bylaw C-8121-2020 is a bylaw to adopt the Highway 1/Old Banff Coach Road Conceptual Scheme to provide a policy framework to guide future redesignation, subdivision and development proposals within a portion of SW-36-24-03-W05M. Schedule A of the proposed bylaw contains the proposed Central Springbank ASP Amendment including the Conceptual Scheme.

Bylaw C-8122-2020 is a bylaw to redesignate the subject lands from Agricultural, General District to Direct Control District to accommodate a mixed commercial development and Residential, Mid-Density Urban District to accommodate the development of a residential community within the eastern portion of the lands. This proposed bylaw is not subject to review by CMRB under the Interim Regional Evaluation Framework (IREF), but has been included for context.

Rocky View County Council held a Public Hearing on Aril 13, 2021, to consider the bylaws. At the same meeting, Council gave second reading to the bylaws and direction to submit this application to the Board for review under the (IREF). Council previously gave first reading to the bylaws on December 22, 2020.
