Note: The following HDR Inc./Calthorpe (Consultants for the CMRB) representatives participated in the meeting remotely: Charles Hales (Senior Planner); Jonathan Schmidt (Senior Planner); Stephen Power (PM).

As information, HDR Inc./Calthorpe Representatives presented the 'Calgary Metropolitan Region Board (CMRB) Growth and Servicing Plan Update' providing an overview of the following: Introduction and Principles; Review of Approach; Key Changes since February; Servicing Plan (note: a copy of the presentation was included in the agenda information package). The final Growth and Servicing Plan is to be presented to the CMRB on May 21, 2021 for approval prior to delivery to the Minister by June 1, 2021.

Discussion ensued following the presentation. As the County's CMRB representative, Reeve Link shared comments previously presented to the

CMRB members expressing concerns regarding the plan process and the need for more information.

#### **RESOLUTION CM-2021-05-50**

WHEREAS the Regional Growth Plan directs growth primarily to urban municipalities and restricts rural growth except in limited areas under the supervision of urban neighbours and the oversight of the Calgary Metropolitan Region Board; and

WHEREAS the majority of growth can freely occur in the urban municipalities with limited Board oversight; and further

WHEREAS the Regional Growth Plan limits the opportunity for rural municipalities to create new employment areas to support municipal sustainability, economic activity, and jobs for Albertans; and

WHEREAS the Regional Growth Plan impacts the agriculture industry by removing the rural municipalities' authority to create the tax base to fund infrastructure required by agriculture; and

WHEREAS the Regional Growth Plan prevents rural municipalities from implementing best rural planning practices for economically viable commercial and cluster residential development; and

WHEREAS the Regional Growth Plan and the provisions therein significantly increase red tape and expenses for municipalities, which is contrary to the Provincial Governments Red Tape Reduction mandate; and

WHEREAS the Regional Growth Plan fails to speak to the need to restrict expansion of urban boundaries; and

WHEREAS the Regional Growth Plan fails to respect the consensus-based approach and mandate to sustain economic growth outlined in the Calgary Metropolitan Region Board Regulation; and

WHEREAS the Servicing Plan is incomplete in that it fails to deliver a comprehensive servicing strategy for the Region, and does not address the logical extension of servicing for future growth; and

WHEREAS the effective date for approved plans to come into alignment with the growth plan will jeopardize plans adopted under the Interim Growth Plan; and

WHEREAS Wheatland County Council has not reviewed all preliminary data sets used by the Growth Plan consultant including assumptions made, indicators, and various models used to create the plan, therefore eliminating the confidence that the Growth Plan is in the best interests of Wheatland County residents, businesses, and future investors;

NOW THEREFORE BE IT RESOLVED THAT Wheatland County Council direct the County's Calgary Metropolitan Region Board representative, Reeve Link, to vote against the approval of the Regional Growth Plan as presented.
